

Jameson® Irish Whiskey Goal-Den Ticket Soccer Sweepstakes **Official Rules**

Sweepstakes Name: Jameson® Irish Whiskey Goal-Den Ticket Soccer Sweepstakes (the “Sweepstakes”).

Sweepstakes Dates: Registration begins at 12:00:01am Eastern Time (“ET”) on **4/1/2026** and ends at 11:59:59pm ET on **8/30/2026** (the “Registration Period”). Note: eligible entries must be received by 6/30/2026 to be included in the grand prize drawing (see below). The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void outside the (50) United States and D.C., and wherever restricted or prohibited by law.

Entrants must fully complete the online registration page with all required information including his/her name, valid email address, phone number (*including area code*), state of residence, zip code and date of birth. After having read and agreed to these Official Rules, and agreeing to receive offers and updates via email from Sponsor, click the submit button to submit your online entry.

- a. Eligible entrants will receive one (1) entry in the associated prize drawings (see below) for completing the online registration. After completing your entry, eligible entrants will have the opportunity to obtain eight (8) additional badges by following the online instructions to participate in various available game play options and engagements. Sponsor is not responsible for any game delay, rescheduling, postponement or cancellation for any reason including but not limited to weather, pandemic, an Act of God, Force Majeure, government regulation or restriction, an act of terrorism, civil disturbance, work stoppage, or any other reason. No substitute prize award or compensation shall be provided by Sponsor in the event of any game delay, rescheduling, postponement, or cancellation for any reason.

- One (1) \$500 gift card towards travel stipend, awarded from the gift card provider as solely determined and designated by Sponsor. Gift card subject to the terms and conditions of the gift card policy from the issuing provider.

NOTE: No alcoholic beverage is part of any prize award. Grand prize winner and guest must be of legal age of majority in his/her state of residence (and at least twenty-one (21)) and will be required to execute and return a liability/publicity release prior to prize award.
